General Rules for Trial

A maximum of 40 dogs will run in all four classes. Order of running will be determined by drawing for position. Dogs can earn MSSA points in all classes. All Classes are judged points then time. At this point the trial will be held in a 100 x 180 sand arena arena at Barb and Dave Moe's at 8265 Fowler Lane, Bozeman. In case of inclement weather we will be at Saddle Peak Arena. Spain Bridge Road, Belgrade, MT.

To be eligible for MSSA Points which would qualify handlers to their Sheep Finals in Afton, Wyoming in July 2020 handlers should sign up with MSSA. It is very easy to do online. Here is the link:
